### **About L&S Pharmacy**

L&S Pharmacy began in 1976 when Richard Logan, Pharm.D. and Ken Seiler, RPh, purchased Hummel Drug in Charleston, MO. Hummel's was a venerable pharmacy with a long history of service to the citizens of Charleston. L & S Pharmacy is now a second generation community practice pharmacy caring for patients, working with other healthcare providers, and continuing to be an integral part of their community's healthcare team. At these pharmacies, patients find local care provider partners, offering personalized, high touch services unavailable in most other pharmacies. Not all pharmacies are the same, and patients receive more than just fast, accurate, and inexpensive prescriptions at L&S.
