#### RESIDENCY SITES



Balls Food Stores is a family-owned supermarket chain local to the Kansas City area. It includes 27 grocery stores with 20 pharmacies. The residency is based in a Price Chopper supermarket in Grandview, Missouri, designed for patient care. The company provides outstanding corporate support for pharmacy services and received the 2018 Pinnacle Award from the APhA Foundation for demonstrating exceptional leadership in enhancing health care quality and medication use.



L&S and Medical Arts Pharmacy are second generation, family-owned community pharmacies in Southeast Missouri. The residency is based out of the Charleston, Missouri site. These pharmacies are nationally known leaders in community practice because of their skills in practice innovation including pharmacogenetics and the incorporation of community health workers into the community pharmacy. They are leaders in CPESN USA working diligently to transform community pharmacy into a patient-centered practice.



The KC CARE Community-Based Pharmacy Residency Program is a longitudinal training experience with emphasis in public health and academia at the KC CARE Health Center, a Federally Qualified Health Center in Kansas City, Missouri. The purpose of this residency is to accelerate the resident's growth beyond entry-level professional competence in the provision of patient-centered pharmaceutical care services to at-risk, resource poor, and/or disparate populations within Kansas City. The clinical resident practices Medication Therapy Services, guided by a collaborative practice agreement with the authorizing physician, to provide medication management for a variety of chronic illnesses including diabetes, hypertension, dyslipidemia, asthma, COPD, GERD, hypothyroidism and HIV. The resident also manages therapy for HIV Pre-Exposure Prophylaxis (PrEP) and Post-Exposure Prophylaxis (PEP) and supports dispensing services in our 340B pharmacy one day per week.
