ABOUT OUR PROGRAM



JORDAN VALLEY COMMUNITY HEALTH CENTER

Jordan Valley Community Health Center (JVCHC) is a Federally Qualified Health Center (FQHC) founded in 2003 to provide medical services to the Springfield community. Today, JVCHC is the largest FQHC in Missouri, serving over 70,000 unique patients, with nine clinics offering medical, dental, behavioral health, and optometry services in five Southwest Missouri communities. JVCHC is recognized for its unique integrated model of healthcare with programming focused on bettering our patients and communities one individual at a time. Clinical Pharmacy Services (CPS) is housed within the family medicine department and is located at the main campus in downtown Springfield with telehealth capabilities to provide services to the satellite clinics. CPS functions under a collaborative practice agreement to provide chronic disease management, consults, and drug information resources. In addition to a pharmacy resident, Jordan Valley has 6 family medicine residents, 2 psychology interns, 1 PsyD post-doctoral candidate, and many health professional students.

Dr. Lisa Cillessen is a Clinical Associate Professor in the Division of Pharmacy Practice and Administration at UMKC School of Pharmacy at MSU and serves as the Residency Program Director for the PGY2 in Ambulatory Care. She earned her Bachelor of Science degree in Cell and Molecular Biology from Missouri State University in Springfield, Missouri and her Doctor of Pharmacy degree from The Ohio State University in Columbus, Ohio. She completed a PGY1 Pharmacy Practice Residency in Ambulatory Care and Academia at Northeastern University and Harbor Health in Boston, Massachusetts. Dr. Cillessen practices as an ambulatory care pharmacist at Jordan Valley Community Health Center, providing chronic disease management services to the uninsured and underinsured.



Paul O Gubbins, PharmD

Dr. Gubbins is the Associate Dean for the UMKC School of Pharmacy at MSU, Vice-Chair and Professor in the Division of Pharmacy Practice and Administration. He earned his Doctor of Pharmacy from the University of Illinois at Chicago (UIC). He then completed the two-year clinical pharmacy residency program at the University of Kentucky in Lexington, and a two-year fellowship in infectious diseases pharmacotherapy at UIC. For over 21 years he was a faculty member at the College of Pharmacy at the University of Arkansas for Medical Sciences in Little Rock, Arkansas. There, he rose to the rank of professor with tenure and served as chair of the Department of Pharmacy Practice and the director of clinical research. He also served UAMS as a member of their IRBs for 20 years including serving two terms as the IRB chair and as a member and leader of their Conflict of Interest committees. He joined the faculty at UMKC in 2014.

A DAY IN THE LIFE OF A RESIDENT

The resident is integrated into the four components of clinical pharmacy faculty: Clinical Practice, Scholarship, Teaching, and Service.

Clinical Practice

The resident spends 3-4 days a week in clinic at Jordan Valley providing clinical pharmacy services under a collaborative practice agreement, focused in chronic care management, and assists with an ADA accredited Diabetes Education Program. The resident participates in all levels of clinical practice, management of an ambulatory care pharmacy practice, and expansion of pharmacy services into new disease states or areas of the clinic. The resident participates in shared visits with the family medicine residents and actively participates in a quarterly interprofessional Grand Rounds. Additionally, the resident participates in MSHP's New Practitioner Workgroup.



Teaching

The resident is integrated into several lectures, skills-based labs, and IPE events at UMKC and will work with our preceptor to develop skills to enhance their classroom experiences. Additionally, the resident serves as a co-preceptor and preceptor for IPPE and APPE students on rotation at JVCHC. Courses the resident is currently integrated into include: Pharmacotherapy I, Pharmacotherapy III Lab, and Pharmacy Practice Leadership, Management and Innovation (other courses are available as well).



Scholarship

The resident completes a required research project. The project will be selected by the resident with guidance from the preceptors and may be clinically or scholarship of teaching and learning based. The resident presents their research at the local and national level and writes a manuscript suitable for publication.



Service

The resident actively participates in meetings at the local, departmental, and school level for UMKC SOP. Additionally, the resident serves on a School of Pharmacy committee of their choice and assists with student organizations. The resident leads a monthly leadership topic discussion for local faculty and staff.


