Residency Program Mission

To provide a diverse learning environment and structured program which will allow the resident to develop the competencies and proficient skills necessary to become a successful psychiatric pharmacist. Upon completion of this program, the pharmacist will be able to independently provide specialized pharmaceutical care to patients with psychiatric disorders in multi-disciplinary and collaborative settings.

Program Overview

The joint PGY-2 program at CBM and NMPRC, in affiliation with the UMKC School of Pharmacy and CPS, has two ASHP accredited positions available for the 12-month period beginning July 1st. As a member of the pharmacy staff, the resident provides pharmaceutical care to Department of Mental Health clients in two state-operated facilities. Residents are active members of multi-disciplinary treatment teams in all settings and work to improve care of the seriously mentally ill. In addition, the residents contribute to improving and enhancing patient care through research and medication use evaluations. Off-site rotation opportunities offer a wide range of experience, ensuring the resident is comfortable in a variety of practice settings. The residency training program prepares the clinician for the challenges of providing primary care and consultation in psychiatric pharmacy practice.

Primary Training Locations

Center for Behavioral Medicine (CBM)

CBM is a 65 bed mental health facility located in the heart of Kansas City, MO. CBM's services include intermediate/long-term adult inpatient treatment (15 beds) and forensic (incompetent to stand trial) treatment (40 beds). CBM also houses Truman Medical Center's (TMC) two acute inpatient psychiatric units. CBM serves as an accredited site for UMKC Psychiatry and Psychology Residency training programs, affording abundant opportunities for interdisciplinary learning.

Northwest Missouri Psychiatric Rehabilitation Center (NMPRC)

NMPRC, located in St. Joseph, MO, houses a total of 108 long-term and forensic beds. This includes 60 inpatients residing on secured wings and 48 inpatients residing in six cottages located on the campus. This long-term rehabilitation center focuses on the treatment of psychiatric forensic patients. The majority of patients are considered to be in long-term placement secondary to permanent incompetence to stand trial or ruling of not guilty by reason of mental disease or defect.

University Health (UH)

University Health Hospital Hill (UH-HH) is a not-for-profit hospital that serves the Kansas City metropolitan area. UH-HH, located in downtown Kansas City, MO, is a level one trauma center and serves approximately 100,000 people yearly. With over 200 inpatient beds, UH-HH is an important fixture in the community serving all who need medical care and is the rotation site for the psychiatry consult-liaison and neurology elective rotations. UH Behavioral Health houses 50 acute inpatient beds, where the resident can gain acute care experience. UH Recovery Health Services (RHS) provides adult treatment for those individuals living with both substance use disorders and one or more psychiatric conditions. The longitudinal outpatient rotation at UH-RHS involves providing pharmacy services that include medication education to patients and staff, outpatient consultation services, and outpatient continuity of care services in a collaborative practice setting.

Clinical Preceptors



Ellie Elliott, Pharm.D., BCPP serves as the Pharmacy Director at CBM and NMPRC. Dr. Elliott is also adjunct clinical faculty for UMKC and University of Kansas (KU) Schools of Pharmacy. She has served on the CPNP Board as Secretary as well as on various committees including the Publications and Online Products Committee, BCPP Question Bank Committee, and Nominations Committee. She assisted in the creation of the CPNP Movement Disorder Training DVD. Dr. Elliott graduated from the University of Nebraska Medical Center and is a previous graduate of our residency program.



Nicole Gramlich, Pharm.D., BCPP, serves as Clinical Manager at NMPRC. Dr. Gramlich is adjunct clinical faculty with UMKC and Creighton University. Dr. Gramlich graduated from St. Louis College of Pharmacy, completed her PGY-1 pharmacy residency at Christian Hospital in St. Louis, MO, and her PGY-2 psychiatric pharmacy residency at Fulton State Hospital in Fulton, MO.



Courtney Iuppa, Pharm.D., BCPP provides clinical pharmacy services to one inpatient forensic unit at CBM and serves as the Residency Program Director. Dr. Iuppa is also adjunct clinical faculty with UMKC and KU Schools of Pharmacy and is a Senior Editor of CPNP's Recertification Editorial Board. Dr. Iuppa graduated from UMKC, completed her PGY-1 pharmacy residency at TMC, and is a previous graduate of our residency program.



Shelby Lang, Pharm.D., BCPP provides clinical pharmacy services to two inpatient units at CBM and serves as the coordinator for APPE student activities. Dr. Lang is adjunct clinical faculty with the UMKC School of Pharmacy. Dr. Lang graduated from UMKC School of Pharmacy, completed her PGY-1 pharmacy residency at the VA Central Iowa Health Care System, and is a previous graduate of our residency program. Dr. Lang is continuing her research in readmission rates for patients with schizophrenia spectrum disorders from her PGY-2 residency year with Dr. Leigh Anne Nelson.



Leigh Anne Nelson, Pharm.D., BCPP conducts psychopharmacy research and provides clinical pharmacy services to an inpatient unit at TMC. Dr. Nelson graduated from UMKC and is now a Professor with UMKC School of Pharmacy. She has previously served on the CPNP Board as Secretary and as Chairperson of the BPS Specialty Counsel on Psychiatry Pharmacy. Dr. Nelson is the primary preceptor for the residents' longitudinal IRB-approved research project.



Debbie Sass, R.Ph., BCPP is a clinical pharmacist at NMPRC. She is adjunct clinical faculty with the UMKC School of Pharmacy and provides staffing services as well as clinical pharmacy services to one unit. She graduated from the University of Nebraska Medical Center.

Research Faculty



Carrie Kriz, MS is a Clinical Research Coordinator. She coordinates both original and pharmaceutical sponsored research at CBM. Ms. Kriz also assists in precepting residents for the longitudinal research project.



Roger Sommi, Pharm.D., BCPP, FCCP conducts psychopharmacy research and serves as a consultant in difficult management cases throughout the state of Missouri. He graduated from the University of Utah and is Associate Dean of the UMKC School of Pharmacy MU Campus and a Professor with UMKC School of Pharmacy. Dr. Sommi is a founding member and past president of CPNP. In addition, Dr. Sommi was recognized as the 2011 Saklad Award Recipient and is actively involved in Phase 2-4 clinical trials, landmark studies such as the CATIE study, and original research. Dr. Sommi assists with the residents' research projects and the research elective experience.

Additional Preceptors

Residents will have the opportunity to work with additional preceptors through elective rotations. Off-site, elective rotations allow the resident to experience a wide variety of practice styles and disease states. Training & Service

Residents are an integral part of patient care services while in the program. Supervision and direction are provided by the preceptors; however, resident independence is expected and encouraged. Required and elective rotations are described on the previous page.

Formal Educational Activities

In addition to the individual supervision received during the psychiatric pharmacy residency, classroom experience is also available through the medical residency training program. All classes are conducted by members of the program's clinical teaching staff.

Residents will have the opportunity to further develop their teaching skills throughout the year. Educational responsibilities include didactic and clinical instruction of pharmacy and medical students, psychology interns, psychiatry residents, and medical staff. "Psychotropics Made Simple" lectures for medical students, psychopharmacology lectures for psychiatry residents, resident rounds with pharmacy students (APPE), and Case Conference and Grand Rounds presentations to the medical staff are activities in which the residents participate. Additionally, satellite video conferencing for these activities is available to further enhance the educational learning environment between NMPRC and CBM. Other presentations during the year include (but are not limited to) periodic case presentations, journal club presentations, and nursing educational in-services, as well as presenting projects and MUEs to the Pharmacy & Therapeutics Committee.

UMKC School of Pharmacy offers a teaching certificate program that is optional for the pharmacy resident. Classes for this program are held monthly from September through May.

Research Activities

Residents have the opportunity to participate in ongoing research projects. Residents are required to complete two MUEs as administrative projects and one research project. The resident is required to formulate a research idea, develop a research proposal, obtain IRB approval when necessary, implement the project, and publish results (when possible) in paper, abstract, or poster form. The resident will submit their research project as a poster at the College of Psychiatric and Neurologic Pharmacists (CPNP) meeting and present results to the facility at Grand Rounds.

Stipend & Benefits

- **Salary:** Contact the program director for current stipend (taxable income funded by CPS).
- **Travel:** Certain expenses related to educational travel will be reimbursed by CPS up to a pre-determined amount. For a current amount and what expenses are covered, contact the residency program director. The amount typically covers expenses related to travel, lodging, meals (up to a per-diem amount) and meeting registration for the Midyear Clinical Meeting, CPNP meeting (includes poster), and Midwest Pharmacy Residents Conference.
- **Leave:** The resident may accumulate 1.75 hours per pay period of sick-time and there are 10 days of paid vacation/personal time per year. The resident is allowed up to three paid days exclusively for interviewing toward the end of the residency year. The resident does not have to use vacation days to attend specific educational meetings. State holidays will be observed when the resident is on-site at CBM and NMPRC.
- **Medical Insurance:** The resident may choose to enroll for medical, dental, and vision insurance. Residents are not covered for the first 30 days of employment. See details of coverage in PSI's personnel manual.
- **Benefits:** See details of coverage per CPS's Personnel Manual for Life Insurance, Long-Term Disability Insurance, Workmen's Compensation, and Unemployment Insurance.
- **Adjunct Faculty:** Residents are eligible for a 12-month adjunct clinical faculty appointment with the University of Missouri-Kansas City School of Pharmacy.

Applications & Qualifications

Applicants should have a Pharm.D. degree, or equivalent experience, with completion of an ASHP-accredited PGY-1 Pharmacy Residency Program and be eligible for licensure in Missouri. Please see separate Application Instructions document for full application requirements. A personal interview will be required of those individuals possessing appropriate qualifications for the position. Further information can be obtained by contacting the program director.
